

Higher Education Emergency Relief Fund Report

Under the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA), Universal Technical Institute (UTI) received relief funds to distribute as emergency financial aid grants to eligible students of our institution. Consistent with guidance received from the U.S. Department of Education, we are making the following information available regarding the process we have used to distribute those funds to students with exceptional need, and the status of our efforts as of June 30, 2021.

- The method UTI is using to determine which students receive emergency financial aid grants and how much they will receive.

UTI endeavors to provide emergency financial aid grants to all UTI students who met the eligibility criteria. In order to receive an emergency student grant under HEERF II, a student must:

- Be a UTI student (including an approved leave of absence);
- Have completed a Free Application for Federal Student Aid **and** have an approved ISIR on file with UTI;
- Have an EFC between \$0-\$5,576; and
- Be a United States citizen or eligible noncitizen as determined by the FAFSA.

Award amounts are determined by each student's financial need, as demonstrated by their [Expected Family Contribution \(EFC\)](#) and the student's proximity to campus. Student grant awards range between approximately \$1000 and \$2300.

- Instructions, directions, or guidance provided by the institution to students concerning the emergency financial aid grants.
